- No credit history checking or income verification;
- Cardholder has his/her own account for direct transfers. Funds can be transferred to the card from your corporate and/or personal accounts located anywhere in the world via SWIFT wire transfer and by Checks/IMO and by e-Gold;
- There no minimum balance frozen on the card (there may be set minimum balance if large amount is withdrawn in currency other then the card currency - no more then 2% from amount of daily withdrawals);
- You have financial privacy. Details about your card are not available to third parties due to strict confidentiality law;
- Assets protection from creditors. Your card deposits are located in other country and are unreachable by creditors;
- SMS/e-mail messaging system allows you to know your card current balance and all changes happened on your account;
- There is an on-line system giving you possibility to review everything happened with your card in past;
- In case of proper application filling and required documents submitting the card is issued in 3 days.

What is this card?

This card is **Maestro®** debit card - a product of **MasterCard®** International. .

The card is intended for:

- Purchases made in shops with POS terminals located in thousands places over the world (not in Internet);

- Withdrawals of cash from cash dispensers (ATM).

Cost of the card is: US\$635 including courier shipping.

**This includes:**

- Maestro debit card issuing;
- First year fee;
- PIN code in securely closed envelope;
- An instruction with methods of your card account replenishment;
- Notification system set up;
- Our personal attention ensuring of efficiency and rapidity of the card issuing procedure;
- Freeing you from personal visit to the bank.

(Shipment by courier service is \$60 or €50 and is included into the above cost.)

Required documents:

- Copy of your passport;
- Original of utility bill that lists your name, or copy of any other document having your photograph (Driver Licence), or photograph of your face near of your opened passport.
